President's Message

To the ISGIDAR Membership,

Graduate students and postdoctoral trainees are encouraged to apply for these esteemed awards. Finally, our program this year will include talks from former trainees of the late Dr. Emily Jutkiewicz. Dr. Jutkiewicz was a longstanding member of ISGIDAR and CPDD, and it is our hope that these talks and resulting discussions will provide an opportunity for our membership to memorialize our colleague and friend and highlight her contributions to our field.

In this year's President's message, I want to focus on donations. Donations are critical for the success and survival of our organization. We have been fortunate to provide the ISGIDAR travel award for trainees each year because of the generous and longstanding support from Drs. Suzette Evans and Richard Foltin. Similarly, the Woolverton award has been generously supported over the years by former Woolverton trainees. Longstanding supporters include Drs. Karen Anderson, Mike Nader, Kevin Freeman, James Rowlett, and myself. These donations are critical for supporting our trainee travel awards. However, I want to focus on and solicit general donations to support annual meeting costs. Each

year, Jack Henningfield at Pinney Associates has made a generous donation in this regard, and we have reduced meeting costs through our relationships with Parthenon and CPDD. Without the support of Pinney Associates and CPDD, it would be difficult to maintain our annual meeting costs without increasing registration fees. Treasurer's Message





SUMMARY REPORT FROM THE OUTGOING TREASURER Dr. Wendy Lynch

ISGIDAR 2024 in Montreal, Quebec, Canada was a fantastic success! We had a strong turnout, plenty of coffee, a delicious lunch, and ice-cold beverages to cap off the day. Skipping breakfast this year (and taking advantage of Montreal's favorable prices) left us with a surplus of \$1,258.27—a win-win!

Food and beverage costs were very reasonable at the venue in Montreal, and thanks to CPDD's management team at Parthenon, we were able to get the Canadian sales tax reimbursed, keeping our food and beverage costs to \$6,300.33. Parthenon also negotiated excellent rates for A/V services, and even without bringing our own projector, the total cost for A/V was only \$737.40.

We had great attendance with 78 paid registrants, including 55 regular registrants (\$100 each) and 23 trainees (\$50 each) grossing the organization \$6,150. We also received generous donations to fund our travel awards and to defray overall expenses. These included \$1,000 from Drs. Richard Foltin and Suzette Evans for the ISGIDAR travel award, \$1,000 from Dr. Karen Anderson, \$250 from Dr. Sally Huskinson, and \$200 from Dr. Michael Nader for the Woolverton Memorial Travel Award, and \$1000 from Pinney Associates for overall expenses.

These donations are vital - they enable us to support travel awardees, offer partial fee waivers for trainees, and provide coffee, a hearty lunch, and refreshments at our business meeting. This year, we supported travel/professional development for two ISIGIDAR awardees, Hannah Carlson and Cesar Ramon Romero Leguizamon, and 1 Woolverton awardee, Lindsey Galbo-Thomma. We also provided a partial fee waiver for 23 trainees.

Looking ahead to our upcoming meeting in New Orleans, we anticipate higher costs than Montreal. To manage expenses, we'll continue to offer coffee-only at breakfast. We also encourage everyone to consider making a tax-deductible donation to support our efforts. Donations can be made online through our ISGIDAR Square Store or by check to our new Treasurer's mailing address (ISGIDARCOM, Justin Strickland, Johns Hopkins University School of Medicine, 5510 Nathan Shock Drive, Baltimore, MD 21224).

Registration for ISGIDAR 2025 will again be handled through CPDD (Registration Link). Fees remain the same: \$100 for full registrants and \$50 for trainees. Trainees are highly encouraged to attend! If a trainee lacks travel funds, we'll waive their registration fee—just email Justin Strickland at istric14@jhmi.edu to request a waiver. Feel free to reach out with any questions about this policy.

On a personal note, this is my final report as ISGIDAR Treasurer after 15 wonderful years. It has been a privilege to serve in this role, and I'm deeply grateful for your support. I'm delighted to pass the ledger book to Justin Strickland, who I know will be a fantastic treasurer for our organization.

Thank you all for your contributions and enthusiasm—here's to an even brighter future for ISGIDAR!

Submit a short paper (maximum of 1500 words, not including references, and a single figure) describing your study (Abstract, Introduction, Methods, Results, Discussion, with the Abstract limited to 200 words) to Greg Collins (collinsg@uthscsa.edu). Pilot projects with few subjects also are acceptable, if the findings are interesting.

The scope of the paper should be consistent with a 20-min slide presentation. Please include paper title, name, mailing address, email, and phone number.

REVIEW: Papers will be reviewed by ISGIDAR officers for scientific contribution, originality, methodology, and clarity.

2023 Business Meeting

Minutes Approved on June 15, 2024, at the meeting in Montreal, Quebec, Canada

2023 Business Meeting

Where: Satellite meeting of CPDD, Denver, CO

When: June 17, 2023

Who: Matthew Banks (President), Wendy Lynch (Treasurer), Sally Huskinson (Secretary), Josh Lile (Past

President), and members

The President, Matthew Banks, called the meeting to order at 3:45 pm

The President called on the membership to approve the business meeting minutes from 2022. There was a motion to approve, the motion was support by a second member, and the membership voted unanimously to approve the minutes.

The President thanked the attendees for coming to ISGIDAR and noted that our attendance felt as though it was up this year (maybe?). The president thanked the speakers for volunteering to talk and noted that he has received feedback on the talks and discussions that followed. The feedback has been positive, and the President noted that many reminisced that this meeting reminded them of ISGIDARs of old, with the lively discussions and banter.

The Secretary's report followed. Sally asked the membership to let her know if they know of anyone not receiving emails who should be. She received undeliverable emails frequently. For the new and current members, she asked that individuals please make sure to let her know their new email address when they make moves to different institutions.

Wendy Lynch gave the Treasurer's report.

- Wendy indicated that she thinks we had the same number of registrants this year compared to last year. There were 73 registrants, 52 were full registrants and 21 were trainees (partial registrants). She believes there are more students that she did not think received the trainee discount and asked if there were students who did not receive the deduction but would like to, to come see her so it can be corrected. She noted, however, that ISGIDAR could use the extra money, and encouraged those who could afford to pay the entire fee to consider letting ISGIDAR keep it. Laughter followed.
- With registration, ISGIDAR made \$6,400, and we did well with donations. Thanks to Jack Henningfield, ISGIDAR received a donation from Pinney Associates for \$1,000. Suzette Evans and Richard Foltin donated \$1,200, Sally Huskinson donated \$200, Mike Nader donated \$200, and Karen Anderson donated \$1,000. In total, we made \$3,600 in donations. Applause followed. Wendy ended by reminding the membership that the donations we receive are so important for the ISGIDAR meeting considering the cost of food, snacks, beer at the business meeting, and coffee.
- This year, the ISGIDAR meeting in Denver was really expensive, but Wendy reported that we have a little surplus from virtual meetings, and that ISGIDAR will be okay. We are about \$3,000 in the red after

this meeting. We can recover the deficit from our money in the bank (~\$11,000), however, ISGIDAR needs to consider the costs for future conferences. Mike Nader suggested we consider not providing breakfast at the next meeting, and there was consensus among the members. The other option would be to raise the registration fee. Ultimately, the membership decided to not have breakfast instead of raising the registration fee. Next year, ISGIDAR will provide coffee and will revisit registration costs next year. It also was noted that Montreal was fairly cheap last time the meeting was there, partly because there are no taxes for our costs in Montreal. The Treasurer report was concluded, and applause followed.

The President reminded the members that Wendy has served as our Treasurer for the past 15 years, out of the kindness of her heart and asked for another round of applause for her service.

Nominations followed. The President noted that he has reached the end of his 2-year term and nominated Sally Huskinson as President. A motion to approve was made and supported by a second member, all members were in favor. Applause followed. The President then nominated Greg Collins as Secretary, all members were in favor and applause followed.

The President asked Josh Lile (outgoing Past President) for any wisdom he'd like to impart. He responded by telling the officers to keep up the good work. Applause followed.

The President asked for member nominations. New members were asked to come up and write their names and email addresses for the Secretary. Applause followed after new members had been nominated.

Wendy and the other officers thanked Matt Banks for his service for two years as President.

ISGIDAR Bylaws

I. Name and objective

The name of this Association shall be International Study Group Investigating Drugs as Reinforcers (ISGIDAR). The objective of the Association shall be to promote interest in, and to facilitate the dissemination of, new information related to drugs as reinforcers, especially as it may relate to human drug abuse.

II. Membership

- 1. ISGIDAR shall be made up of Members and Sponsoring Members. Any person holding an academic or scientific degree or working toward such a degree and who is actively engaged in or interested in research related to drugs as reinforcers shall be eligible to become a Member. Sponsoring Membership shall be offered to organizations with an interest in basic or applied research in the field of drugs as reinforcers.
- 2. Application for Membership: Current ISGIDAR members can submit nominations at the annual business meeting or submit nominations in writing to the President at any other time during the year.
- 3. Election to Membership
 - a. Individuals nominated at the annual meeting will be elected to membership by a yes vote of 90% of the governing body.
 - b. Individuals nominated directly to the President will be elected to membership by unanimous vote of the Board of Officers. In this case, the results of the election will be announced at the next business meeting.
- 4. Membership may be rescinded by action of the Board of Officers of ISGIDAR for justifiable causes. Paid dues must be returned to the ex-member along with notification of termination of membership in writing and an explanation of the reason for removal. Any member so removed may appeal this action to the Membership at the first meeting of ISGIDAR occurring more than 30 days following notification of termination of membership by board action.

III. Governing Body

- 1. Members present at each business meeting of ISGIDAR constitute the governing body provided a quorum is met. A quorum consists of at least two members of the Board of Officers plus at least 10 members. Each Member has one vote. The Membership present at the meeting can decide by simple majority vote about the following items:
 - a. Minutes of the previous meeting
 - b. Acceptance of financial report by the Treasurer
 - c. Dues and Registration Fees
 - d. Future meeting places
 - e. Adoption of a working budget
 - f. Election of officers
 - g. Varia

2. Changes in the bylaws may only be brought about following full discussion at the business meeting. A two-thirds majority of the members present must approve all such changes. Changes proposed at a given business meeting may be voted upon at the same meeting unless a majority of those present vote to have the proposed change distributed by mail to the membership with the announcement that the proposed change will be voted upon at the next business meeting.

IV. Officers

- 1. The Board of Officers of ISGIDAR shall be made up of members who serve as:
 - a. President
 - b. Past President
 - c. Secretary
 - d. Treasurer
- 2. The President shall be elected by majority vote of the governing body for a 2-year term. The term of office begins at the close of the meeting at which a President is elected and ends when the term of the President's successor begins. An individual may serve more than one term as President, but the terms may not be sequential.
- 3. The Past President will serve on the Board of Officers for two years following the presidency for the same term of office as the President.
- 4. The Secretary shall be elected for the same term of office as the President by majority vote of the membership present. The Secretary may be re-elected for four (4) additional, sequential terms.
- 5. The Treasurer shall be elected for the same term of office as the President by majority vote of the membership present. No restrictions are placed on the number of times the treasurer may be reelected.
- 6. Powers and Duties of the Officers
 - a. President
 - 1. Arrange and set the agenda for the annual scientific and business meetings
 - 2. Preside over the annual scientific and business meetings
 - 3. Preside over all meetings of the Board of Officers
 - 4. Engage in fundraising and contribute to the financial stability of the organization
 - 5. Perform such other duties as are incident to the office, including contributing to the long-term stability of the organization and meeting the objectives described in the bylaws
 - b. Past President
 - 1. Ensure a smooth transition for the President
 - 2. Provide input on the future, goals, direction, and function of the organization
 - 3. Complete all agenda items that were not completed during the prior term when serving as President
 - 4. Assume the President's duties if the President is unable to act
 - c. Secretary
 - 1. Keep the minutes of ISGIDAR business meetings
 - 2. Edit and disseminate at least one edition of the Newsletter each year
 - 3. Serve as Parliamentarian of the organization
 - 4. Keep and annually update the master membership list

d. Treasurer

- 1. Receive, disburse, and duly account for all sums of money belonging to ISGIDAR
- 2. Submit a written financial report each year to the Board of Officers and at each Business Meeting.
- 3. Assist the President in fundraising and contributing to the financial stability of the organization
- 7. The Officers shall represent ISGIDAR to the public.
- 8. The President may appoint additional officers as needed. Appointed officers will have defined roles as specified by the President, they will serve at the discretion of the President, and their terms of office will terminate at the end of the President's term of office. An incoming President may reappoint the same individual holding an appointed position for an additional term of office.

V. Meetings

- 1. Annual Business and Scientific Meetings shall be the responsibility of the President. The President or Secretary will notify all members at least 30 days prior to any business meeting of ISGIDAR
- 2. Scientific Meetings may be arranged in any format suitable for the communication of information and acceptable to the Board of Officers. Local arrangements will be made by the President or another individual whom the President may appoint.
- 3. Whenever possible, business meetings will be held in conjunction with scientific sessions. Business and scientific sessions will, insofar as possible, be held at or near the time of other national or international meetings of scientists likely to be of interest to and participated in by members of ISGIDAR.
- 4. The Board of Officers shall meet at such times and places as are mutually agreeable to Board Members. All Board Members must be notified of such meetings at least ten days prior to the meeting.

VI. Dues

1. Annual dues become payable on or before the annual business meeting of the membership year. The amount of the annual dues and registration fees shall be recommended by the Board of Officers and decided upon by majority vote of the governing body at any business meeting.

VII. Committees

1. Permanent or ad hoc committees shall be established when necessary and their members appointed either by the President or by vote of the governing body at a business meeting.
